TEST RESULTS

How long will the Potomac® Emergency Escape Mask provide protection? For every mask, the protection time will differ depending upon many variables—a few of which are the air temperature, humidity level, type of agent and concentration level of the agent. Therefore, it is impossible to give an exact time. The table below lists some of the tests conducted at distinguished independent laboratories.

Conducted extensive testing on the mask body to make sure it would stand up against chemical agents.

*The HCN test was stopped after 32 minutes which is more than twice the European norm. From our experience, if the test had been completed, the Potomac mask would have lasted close to 60 minutes.
